



Historical Statistics of FDI in Taiwan




# FDI by Industry since 1952


# Taiwan Stock Exchange Weighted Index in The Last Decade


# Foreign Investor Taiwan Stock Trading Volume (Total Amount)




- Foreign investors averagely hold **40%** of the market value of all listed stocks.

## GDP Growth Rate in The Last Decade




## 2024 GDP Growth Forecast



(US\$ Billion)





# Taiwan Pension Fund Scale


Taiwan Pension Fund AUM (US\$ Billion)

# Taiwan Pension Onshore/Offshore Asset Allocation



Total Asset of Taiwan Insurance Industry (US\$ Billion)




- Among the total assets of US\$1,106 billion, life insurance accounted for 98.7%, while 1.3% for non-life insurance.
